ARTICLES OF INCORPORATION

OF

N O W LEGAL DEFENSE AND EDUCATION FUND, INC.

TO: The Recorder of Deeds, D. C.
Washington, D. C.

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators of a corporation, adopt the following Articles of Incorporation for such corporation pursuant to the District of Columbia Non-Profit Corporation Act of August 6, 1962 (76 Stat. 265; Public Law 87-569; D. C. Code, Chap. 10, sec. 29-1001, et seq.):

FIRST: The name of the corporation is:

N O W LEGAL DEFENSE AND EDUCATION FUND, INC.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purposes for which the corporation is organized are:

1. To be operated exclusively for charitable, educational, and/or scientific purposes within the meaning of sections 501(c)(3) and 170(c)(2) of the United States Internal Revenue Code of 1954 (26 U.S.Code) and of any subsequent amendments or revisions thereof.
2. To provide legal services to bring women into full participation in all activities of American life by securing for them their full legal rights under the Constitution.
3. To conduct research, collect, collate, acquire, compile, and publish facts, information and statistics concerning

facilities, services, privileges, rights and opportunities, of all kinds, the use or enjoyment of which is denied, restricted, or otherwise conditioned, to anyone on the basis of race, color, sex, religion or national origin, and to combat any such discrimination by legal action.

4. To supply legal counsel, either by the corporation's own officers, employees or members, or by others as requested by it, to persons and groups whose civil rights and liberties are threatened or infringed or violated.

FOURTH: The corporation will have members who shall have the qualifications, shall be elected, and shall have the rights, as set forth in the By-Laws of the corporation.

FIFTH: The officers and directors of the corporation shall have the qualifications, shall be elected, and shall have the powers and duties, as set forth in the By-Laws of the corporation.

SIXTH: In the event of dissolution, no property of the corporation, nor any proceeds thereof, shall inure to the benefit of any member or any other private individual, but all remaining assets shall be distributed to such organizations as shall qualify under section 501(c)(3) of the Internal Revenue Act of 1954 as amended.

SEVENTH: No part of the net earnings of the corporation shall inure to the benefit of any member or any other private individual, except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes.

EIGHTH: No part of the activities of the corporation

shall consist of carrying on propaḡanda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office.

NINTH: The address of the corporation's initial registered office is 4577 Indian Rock Terrace, N.W., Washington, D.C. 20007, and the name of its initial registered agent at such address is: Jane Moore.

TENTH: The number of directors constituting the initial Board of Directors is three, and the names and addresses of the persons who are to serve as initial directors until the first annual meeting or until their successors be elected and qualify are:



Pursuant to the provisions of the District of Columbia Non-profit Corporation Act, the undersigned adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is: NOW Legal Defense and Education Fund.

SECOND: The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-profit Corporation Act: Article Eighth is amended to read:

No part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, to an extent which would disqualify the corporation for qualification under §501(c)(3) of the Internal Revenue Code of 1954 and of any subsequent amendments or revisions thereof, and the corporation shall not participate or intervene in any political campaign on behalf of any candidates for public office.

THIRD: The amendment was adopted in the following manner:

The amendment was adopted at a meeting of members held on October 4, 1979 at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting were entitled to cast.

THE UNDERSIGNED, pursuant to the District of Columbia Nonprofit Corporation Act, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is NOW LEGAL DEFENSE AND EDUCATION FUND (the "Corporation") *INC.*

SECOND: The following amendment to the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Nonprofit Corporation Act:

Article First ~~which states~~, "The name of the corporation is: NOW Legal Defense and Education Fund" ^{is hereby} deleted in its entirety and replaced by the following Article First:
